
Bonus points Premier Credit Card Offer

Terms and Conditions

1. These Offer Terms and Conditions (the "Offer Terms") are an agreement between you and us. They apply when you successfully apply for an HSBC Premier Credit Card (an "Eligible Card") between 4 January 2019 and 2 March 2019 (the "Offer Period"). These Offer Terms apply in addition to and should be read together with the HSBC Credit Card Terms and Conditions and the HSBC Premier Credit Card Reward Points Rules. In the event of any conflict between these Offer Terms and the HSBC Credit Card Terms and Conditions or Reward Points Rules, these Offer Terms will apply.

2. In these Offer Terms "we", "us" or "our" means HSBC UK Bank plc.

Eligibility criteria for this offer

3. To be eligible for the offer bonus reward points (the "Offer Points") described below, the following requirements must be met:

- a.** you are not an existing HSBC Credit Card holder and have not held a Credit Card with HSBC within the six months prior to the start of the Offer Period;
- b.** you must successfully apply for an Eligible Card during the Offer Period;
- c.** the account for your Eligible Card (your "Credit Card Account") must be opened and purchase(s) or a balance transfer to the value of at least £1,000 made within 30 days of the opening date (a "Qualifying Action"). Any amount which is refunded or reversed before we assess your eligibility for the Offer Points will not count towards the minimum transaction value;
- d.** a Balance Transfer fee will be charged for each balance transferred to the Eligible Card. The fee (and 0% introductory rate period where applicable) for balances transferred within 60 days of account opening are set out in your Credit Card Agreement;
- e.** your Credit Card Account must not be closed before the date we apply the Offer Points.

The Offer bonus reward points

- 4.** If you meet the requirements for this offer as described above, you will be entitled to 10,000 bonus reward points which will be applied within 90 days of the Qualifying Action.
- 5.** We will offer 10,000 bonus reward points per Credit Card Account opened and meeting the qualifying criteria. Additional cardholders are not eligible for this offer.

The Offer Period

6. The Offer Period is between 4 January 2019 and 2 March 2019 (inclusive). Any Credit Card applications received after this date will not qualify for the offer.

7. We may withdraw this offer before the end of the Offer Period without notice. If we do withdraw the offer, we will put a notice on our website. Any applications received after we have withdrawn the offer will not qualify for this offer.

General Terms

8. You can only take advantage of this offer once. This means that if you take out more than one Eligible Card (whether in your sole name or as an additional cardholder), we will only award the Offer Points the first time you successfully apply for an Eligible Card and meet the qualifying criteria, and will not accept further applications from you for this offer.

9. We will not transfer balances between cards operated by members of the HSBC Group. Any request to do so will not be processed. The HSBC Group means HSBC UK Bank plc, its subsidiaries, associated and affiliated companies and includes first direct, Marks & Spencer Financial Services plc and John Lewis Financial Services Ltd.

11. We may refuse any application for a product or service.
